ENTRY PROCEDURE

Submit 1 or 2 (no more) FRAMED photographs with hanging wire attached. Alternate presentations such as Gallery Wrap, encaustics, etc. will be accepted if done in a professional manner. APG may reject any entries not prepared for hanging. Size limit 40" longest dimension.

Label back of each frame with your name, phone# and title of piece. Any signature or name on front will be masked for anonymity.

Complete entry form. Be sure all information is correct and CLEARLY written. The information on this form is used to create wall labels. APG retains 30% commission on works sold from the exhibition. Include a price for both unframed and framed pieces. Keep a copy for yourself.

Hand deliver completed form and payment along with your one or two photographs (ready to hang) to the APG gallery noon-4 September 4,8,9,10,11, (Not before or after) Please be prepared to retrieve pieces not selected the following week.

Those selected for the show will be listed by name on the APG web site along with an optional link to their personal site.

The composition of the show will be at the juror's discretion. Many who enter will not be chosen.

Annette Cone-Skelton is a prominent Georgia artist and President/CEO/Director of **The Museum of Contemporary Art of Georgia**. MOCA GA collects and archives significant, contemporary works by artists of the state of Georgia. ELIGIBILITY

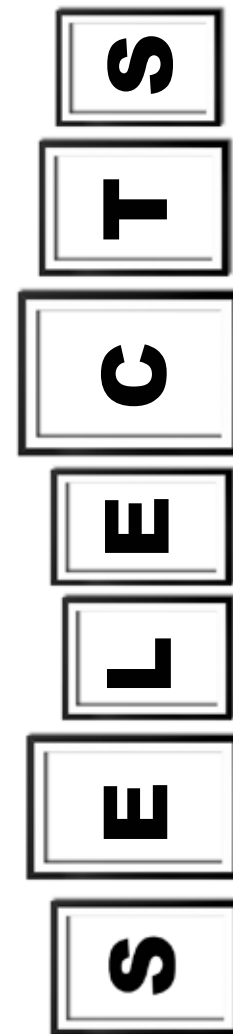
